Conditions of entry:

1. The Tattersall's Award for Enterprise and Achievement shall be awarded once for each calendar month unless, in the opinion of the judges, there is no entry of sufficient merit.
2. The Award shall be made to the entrant who, in the opinion of the judges, has shown the greatest degree of enterprise in pursuit of a worthwhile goal.
3. The winner may be an individual, or where a number of persons have acted in concert, a group. The individuals will receive a trophy to commemorate their achievement and a sum of \$5,000 will be donated to a club, institution or charity nominated by them in advance and approved by the judges.
4. Once in each calendar year, at a time to be nominated by the Trustees of the Estate of the late George Adams, the judges shall choose from winners of the Award one outstanding entry to receive the special Annual Tattersall's Award for Enterprise and Achievement. This shall likewise carry a trophy for the individual or individuals who performed the acts, plus a cash prize of \$15,000 to go to a single individual winner or be shared amongst a greater number where the award is made to a group acting in concert. In addition, a sum of \$75,000 shall be paid to the approved club, institution or charity nominated in the original entry.
5. To be eligible for the Award, entrants should at the time of achievement be resident in Victoria, Tasmania, ACT or Northern Territory.
6. To be eligible, entrants must agree that the names of the winner, the feat for which it was awarded and the body to whom they wish the cash prize to go shall be made public by Tattersall's.
7. Notwithstanding any of the above, the decision of a majority of the judges shall be final at all times. They shall have the power to accept or reject any entry.
8. The competition shall continue until such times as the Trustees choose to discontinue it. The Trustees of the Estate of the late George Adams also reserve the right to vary the prize money at any time at their discretion.
9. To be eligible for consideration, entries should be made on an official entry form and be sent to Tattersall's Award for Enterprise and Achievement, Locked Bag 888, St Kilda Road Central, Melbourne Victoria 3004.
10. It is a condition of the acceptance of an Award that the recipient authorises the Trustees to use all photographs, video footage and the like of the recipient, on behalf of the Trustees for promotional purposes.
